ALL that certain piece and parcel of land situate and being at Port Greville, in the County of Cumberland and Province of Nova Scotia, and bounded as follows:-

ON the east by lands of John Hazel;

ON the north by lands of Amasa Parsons;

ON the west by lands of Joshua Welsh;

ON the south by lands now or formerly owned and occupied by the said Ralph Parsons, containing sixteen acres, more or less;

BEING the lands contained in a Deed dated February 8, 1902, made between Joseph Rector, et ux., of the one part, and Charles Parsons, of the other part, and recorded in the Parrsboro Records at the Registry of Deeds at Amherst, NS in Book 23, at Page 125.

SAVE AND EXCEPT ALL that certain lot of land situate at Port Greville, in the County of Cumberland and Province of Nova Scotia, bounded and described as follows:-

BEGINNING at a stake on the westerly boundary of the Parsons Road, so-called, and being at the southeast corner of lands presently held by Gordon Hatfield;

THENCE in a westerly direction following the course of the Rector Brook, so-called, to a point which intersects the Ratchford River;

THENCE in a southerly direction following the course of the Ratchford River to a stake and old wire fence, being at the northwest corner of the Harvey property, so-called, being recorded at the Registry of Deeds at Amherst in Book 275, at Page 247;

THENCE in an easterly direction following the course of the wire fence, and the northerly boundary of the Harvey Property to a large tree bordering the northeast corner of the Harvey property where it intersects the Parsons Road;

THENCE northerly along the Parsons Road to the place of beginning.

ALSO SAVE AND EXCEPT the Parsons Road or Red River Road, so called.
