ALL that certain lot of land situate in Springhill, in the County of Cumberland, bounded as follows:

BEING on the southern side of a proposed Street, to be called "Bent Street", said street running east and west from the terminal of the southern end of St. James Street and Princess or Hospital Street;

BEGINNING at the northeastern corner of land owned by one Babineau, being the southwestern corner of the said Bent Street; and

THENCE running easterly along said Bent Street, a distance of Two Hundred Fifty Feet (250') to a stake;

THENCE southerly, preserving a uniform width, a distance of Five Hundred Fifty Feet (550') to a stake;

THENCE westerly, a distance of Two Hundred Fifty Feet (250') to land of the aforesaid Babineau;

THENCE northerly along the said Babineau line, a distance of Five Hundred Fifty Feet (550') to the southern boundary of the said Bent Street, the place of beginning.
