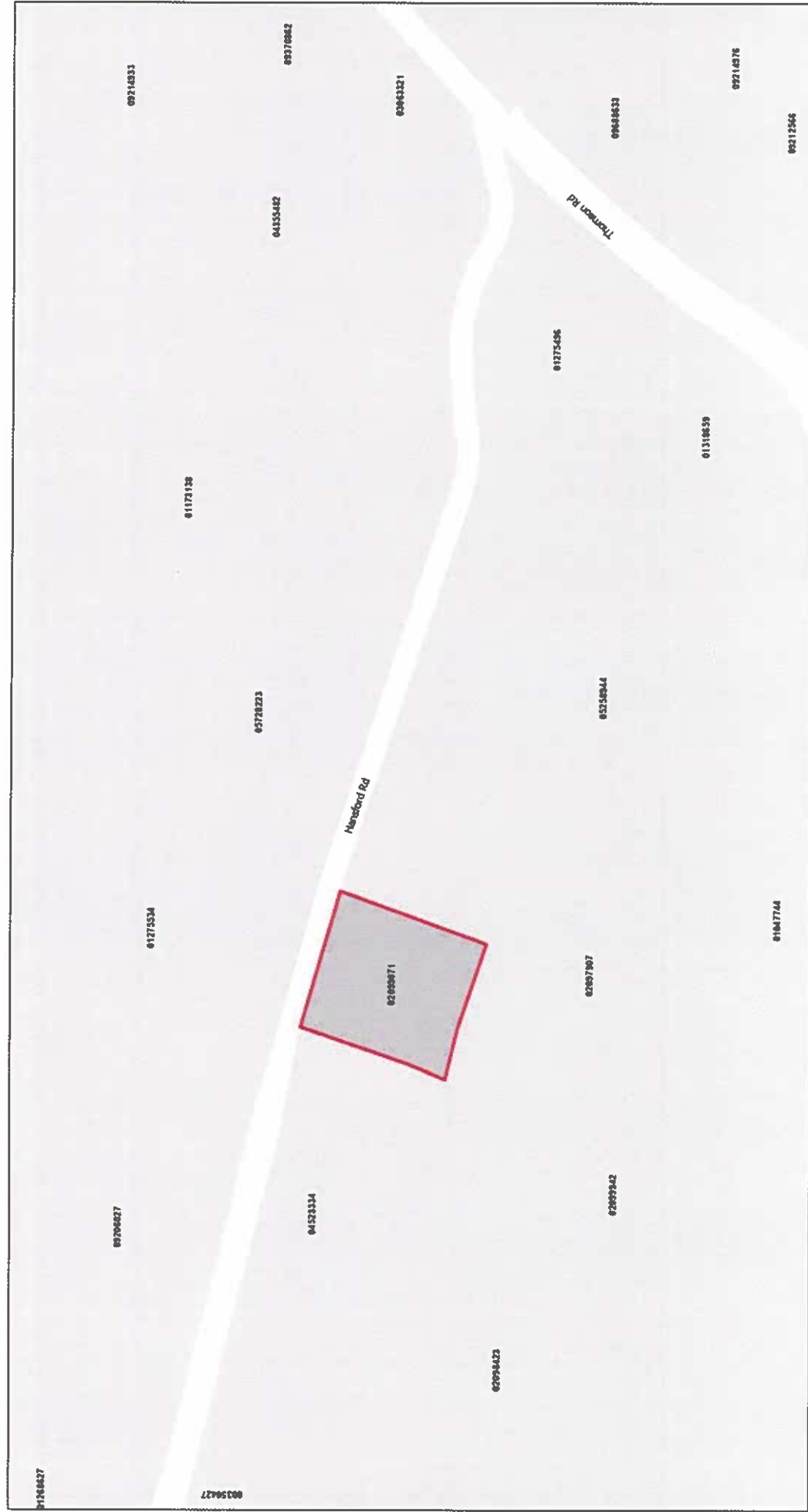

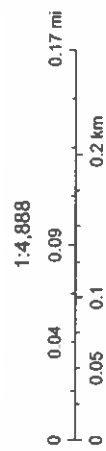

BEGINNING at the intersection of the eastern boundary of the lane leading to the Viona Hudson property and the southern boundary of the Hansford Road;
