All that certain piece or parcel of land situated in the Village of Joggins, County of Cumberland, Province of Nova Scotia, bounded and described as follows: BEGINNING at a point on the Easterly side of the Road leading from Joggins to Lower Cove, said point being the Northeasterly corner of a lot owner by Mrs. Sheila Symchuk; thence in an easterly direction a distance of seventy-five (75) feet to a corner; thence at right angles in a northerly direction a distance of fifty (50) feet until it reaches land of Mrs. Elizabeth Perry; thence in a westerly direction a distance of seventy-five (75) feet to the Eastern side of the Lower Cove Road; thence southerly a distance of fifty (50) feet to the place of beginning.

BEING the lot of land conveyed by the Municipality of Cumberland by Tax Deed to the late Murray Reid dated the 8th day of December A.D., 1971, and registered in the Registry of Deeds Office in Amherst, Nova Scotia, in Book No. 285 at Pages 149-150.
