DESCRIPTION

ALL that certain piece or parcel of land situate at River Hebert and being on the North side of the main road leading from River Hebert to Joggins Mines and described as follows: viz:

BEGINNING at a stake on the margin of the said main road at the southwest corner of a lot of land now owned and occupied by Joseph H. Rockwell;

Thence continuing westerly along the margin of said main road thirty-one feet to the margin of Pearl Street;

Thence continuing northerly along the margin of Pearl Street about one hundred and forty-four feet to a stake, said stake being a straight course with the old Joseph H. Rockwell lot on the rear;

Thence easterly along line of land owned by Augustine Wood to the northwest corner of the said Joseph H. Rockwell old lot;

Thence continuing southerly along the old Rockwell line about one hundred and forty-six feet to the margin of the first named main road, the place of beginning.
