ALL THAT lot of land situate at River Hebert and being on the West side of Pearl Street, being shown as Lot X on a Plan of Subdivision of lands of Charles T. Shipley at Pearl Street, River Hebert, dated the 5th day of August, 1981, prepared by Daniel B. Burke, N.S.L.S., and recorded at the Registry of Deeds for the County of Cumberland, Amherst, Nova Scotia as Plan No. P-1781 (the Plan); and being more particularly bounded and described as follows:

BEGINNING at a survey marker on the southeast corner of Lot Y as shown on the Plan;

THENCE South 02 degrees 43.60 minutes West a distance of 60 feet to a survey marker;

THENCE North 89 degrees 23.10 minutes West a distance of 181.00 feet to a survey marker;

THENCE North 01 degrees 30.50 minutes East a distance of 66.68 feet to a survey marker at the southwest corner of Lot Y;

THENCE South 87 degrees 16.40 minutes East a distance of 108.29 feet to the place of beginning.

CONTAINING 11,502 square feet, more or less.
